## **Details of Claim**

1. The Claimants are local authorities within the meaning of Section 270(1) Local Government Act 1972. Both Claimants are also the local highway authority for their respective administrative areas.
2. The Claimants seek an injunction pursuant to section 222 Local Government Act 1972, section 130(5) Highways Act 1980 and section 37(1) Senior Court Act 1981 to prevent further and apprehended acts of public nuisance on the highway and trespass on the highway, including trespass by tunnelling under and adjacent to the highway. The activities complained on, and which the Claimants seek to restrain, are being conducted by those associated with the environmental campaign groups Just Stop Oil, Extinction Rebellion and Youth Climate Swarm.
3. Pursuant to the Local Government Act 1972, s222 and the Police and Justice Act 2006, s27, the Claimants seek to attach a power arrest to the injunction order.
4. The Claimants will claim that, without an injunction to prohibit further acts of public nuisance on the highway and trespass, the Defendants will cause significant disruption to the highways and petrol stations in the Claimants' administrative areas as part of, and in pursuit of, their anti-fossil fuel protests, and also commit further acts of trespass.
5. The Claimants' administrative areas house the majority of the fuel terminals for the South East of England, which is why it is apprehended that they will be a target of these protests, along with the evidence of protests that have taken place in the administrative area of Thurrock since 1 April 2022. The apprehended action would, if not restrained by an injunction, cause a fuel shortage for the South East of England that would have a significant impact on the public and businesses generally, as well as the emergency services. The protest activities which the Claimant seeks to restrain also risk serious harm to the public and others.
6. In summary, the Claimants' Claim is for an injunction to:



- i. restrain acts of public nuisance (that being the obstruction of the highway) that have occurred in the administrative area of Thurrock, and which are apprehended to recommence and escalate on 25 April 2022; and
  - ii. restrain acts of trespass (and particularly the act of tunnelling under or adjacent to the highway) that have occurred in the administrative area of Thurrock, and which are apprehended to recommence and escalate on 25 April 2022; and
  - iii. restrain apprehended acts of public nuisance (that being the obstruction of the highway) and trespass in the administrative area of Essex County Council, which are apprehended to commence on 25 April 2022.
7. At the time of issuing this Claim, the Claimants have named 222 named Defendants who have been selected by reference to arrest data supplied by Essex Police. Each of the named Defendants appears on the schedule of arrests exhibited at Exhibit [MC/2] to the witness statement of Morgan Cronin, which details the Defendants alleged wrongdoing in connection with the protests. Further, for the reasons set out in the witness statements of Morgan Cronin and Adewale Adesina, the Claimants reasonably apprehend that these Defendants will commit further acts of trespass and/or public nuisance on the highway. A copy of the schedule of arrests is also attached to these Details of Claim.
8. Further, the Claimants bring this claim against Persons Unknown, as defined in the Claim Form. This has been necessary for the following reasons:
  - a. It has not yet been possible to identify all those persons who may be defendants to the Claim, despite the significant efforts made in this regard;
  - b. Given the profile of the protestors and the protest groups associated with the protest (including the size of the group, the fluctuation of the group, the fact that both Extinction Rebellion and Just Stop Oil are actively recruiting new members, and that the protestors who are known have a profile of being from the length and breadth of the country) it is far more likely than not that people will attend the administrative areas of Thurrock and Essex County Council to protest in the

manner complained of in the Claimants' evidence, who have not yet attended, and who would not otherwise be covered by the injunction without a persons unknown order.

AND the Claimants Claim

- (1) The injunctive relief set out in the Draft Injunction Order;
- (2) A power of arrest, as set out in the Draft Injunction Order;
- (3) The alternative service orders set out in the Draft Injunction Order;
- (4) Costs.
