2.3 Matters Arising

80. Update on Thematic Review

- Not yet finished and will be some time before completely finished
- Was requested following a Full Council meeting where concerns were raised about the increase in serious youth violence and knife crime among young people in Thurrock, so is not specific to an individual, it is looking more broadly
- Independent report writer is in place
- Timeline for completion is 9-12 months

Board requested that the LSCP, as commissioners of the report, bring this back to a future meeting.

3.0 Performance

3.1 Essex Police Crime Performance Report – attached **RESTRICTED**

- Overall down 2.8%
- ASB increased due to COVID breaches, car cruising and nuisance motorbike
- Assaults with injury down 4.3% and without injury down 5%
- Increase of 35% overall in sexual offences no specific reason why
- Many sexual offences reported are linked to domestic offences
- Personal robbery down 13.1%
- Residential burglary down 13.2%
- Theft of/from motor vehicles still decreasing well
- Hate crime increased 16.4% high reporting period in last few months, extra 81 offences compared to same period last year – no specific areas, offenders or types to be significantly concerned about

The Board thanked Terry for his update and had no questions.

3.2 <u>Essex Police Perception Data</u> – shared

Recent survey for Q1

73% of residents think local police are doing a good job, up from 61% last year.

Only 31% felt informed about what the police were doing in their local area, down from 44%. 68% said they had confidence in local policing, up from 58% last year. Pre-existing methods of engaging with communities e.g. Coffee with a Cop stopped due to COVID-19 but now restarting and looking to attend face to face Community Forums again.

Thurrock residents felt least informed about what Thurrock police are doing compared to the rest of Essex – good social media posts but looking at posters etc. to better engage, especially with those that don't use social media.

Cllr Redsell thanked police for quick response to motorbike nuisance during recent weekends.

TF has developed a quad bike proposal specifically for Thurrock which has passed the first stage with Assistant Chief Constable and is now with the Chief Constable for a decision.

3.3 Incidents of note:

 M25 Insulate Britain protests at Junction 31 Monday 13th September.

Essex Police removed protestors in 1hr 35 mins, other forces took 4-5 hours.

CPT officers tasked with daily high vis patrols to prevent future events.

Had to explain legalities to every protestor and provide alternative sites for protest before arresting for disrupting the highway. Now have High Court Injunction which gives police power to remand and potentially send to prison.

JRo noted the positive response from Essex Police.

2. Protests

Thameside Theatre protest 22/09, low-key attendance from PCSO's but very peaceful.

Anti vax protests – have to balance the spreading of misinformation with the right to protest.

Small group carrying out small protests which intel team are monitoring.

No concerns at present

JRo has concerns around locations they are protesting at as could be dangerous, e.g. roundabouts.

TF can ask them to move to an alternative suitable location. Overall decline in anti vax protests as most people who want the

vaccine have already had it.

SM – possible concerns around care homes as date in October when all care home staff have to be vaccinated.

TF – will monitor healthcare/care home settings etc. where people may be more vulnerable to being intimidated and will have a robust police approach.

3. Ensign Buses

Criminal damage to buses.

Op Snare - Covert and overt patrols on buses.

Did see a break in offences but recent reports of attempts and one recent incident in Tilbury.

Highlighting to wider community the action that is being taken to reassure the community.

Aim to make communities feel safe, keep the buses running and prevent criminal damage.

Thurrock CPT led by TF managing investigations going forward.

HO raised concern that whilst ASB had reduced at Lakeside it had worsened significantly this week between Lakeside and Chafford Hundred Station.

TF to look into and meet with Howard to discuss the issue

4. Boxing event 11th September.

Some disorder at East Tilbury Recreation Club.

Investigations into licensing of the event have found tensions between 2 families of competitors from the travelling community. Call made to police reporting someone was in possession of a handgun but not substantiated.

Firearms officers arrived and then brawl started, resulting in 6 arrests.

Monitoring community impact and local tensions but nothing of note.

3.4 Changes to hate crime recording

Essex Police are now recognising gender and sex as protected characteristics falling under hate crime.

TF noted that it won't include domestic offences

6.3 <u>Update report on Priority 5</u>

MC presented summary of the report written for the Hidden and Extreme Harm Committee.

Focus around protecting children and vulnerable adults from the risks of radicalisation.

10 point self-assessment toolkit for local authorities which we RAG rate – 3 currently at amber.

1 amber around training programme, host 1 every 2 months to cover WRAP and hate crime but identified no mechanism to monitor so need to conduct training needs assessment.

Training currently under review of Home Office.

1 amber around venue hire. 3 policies signed off to go to schools, licensed premises and community venues.

Schools have a duty to Prevent.

Community and licensed premises have no duty but hope they will embrace and use the guidance for any lettings of their premises to show due diligence to Prevent agenda.

1 amber around community engagement – Difficult to do closer engagement recently due to COVID but have IAG, police challenge

7. Health and Wellbeing

7.1 Overview of strategy

Will be finalised March 2022 and run through to March 2026. Consulting on this until December and can bring back to this board in December.

Vision is to level the playing field both within Thurrock and between Thurrock and other areas.

10 year life expectancy gap between least and most affluent people in borough.

Healthy life expectancy for women (time spent living in 'good health') has an 8 year gap, roughly 22 years in poor health.

Kings Fund work highlights wider health determinants that influence the uneven landscape.

Structured around 6 domains which each link to the Council's 3 key priorities of People, Place and Prosperity:

- 1. Quality care centred around the person
- 2. Staying healthier for longer
- 3. Building strong and cohesive communities
- 4. Opportunity for all
- 5. Housing and the environment
- 6. Community Safety
 - Strengthen local approaches to reducing crime
 - · Improve support to victims/survivors of crime
 - · Reduce perpetrator activity and re offending
 - Protect residents from experiencing crime, with a focus on vulnerable groups

7.2 Report of Thurrock DAAT

1 full time criminal justice worker employed now in inclusions visions, advertising for 2nd post.

Struggling to recruit to full time worker support role.

Inclusions repurposing community outreach worker to support criminal justice worker temporarily.

Difficulty recruiting as central funding is limited for DAAT.

Recruited regional post for impatient residential detox role, based within Essex County Council.

Treatment for opiate use has slightly declined, partly due to rise in successful completions.

Treatment for non opiate clients – increase in number of successful

completions.

Alcohol treatment levels have declined slightly but also an increase in those completing treatment.

Treatment declined slightly for young people but increased complexity so majority are being seen face to face.

43 in treatment plus another 20 for hidden harms where parents or siblings are in treatment.

Strong treatments exits for young people in past year.

No referrals disclosed through Op Cloud initiative but confident we will have some, but enter as a self-referral rather than disclosing that they have received the number through their dealers number, when police have seized the dealers phone.

Pilot of bouvidol in HMP Chelmsford which is a sub dermal implant with methadone type gel which aims to keep users stable for long periods of time within the community.

ML – Probation Service also have some funding for recovering from dependencies.

JRo – how much work takes place in prisons to get people off of drugs and alcohol while in custody?

ML – varies prison to prison but there are detox arrangements for people inducted into prisons.

Good dependency recovery wings, especially in Chelmsford.

COVID has affected access to services due to reduction in movements around prisons and isolation.

Often challenging once released as can be difficult to join the gap in prescribing from in prison to once released especially if no confirmed accommodation.

SM – offer for conversation with KM and ML to discuss joining up all medications/treatments in prison and in the community as service users may not be signed up to GP's, able to access pharmacies etc.

JRo – how do we prevent the drug cycle in normal life if there is able to be one in prisons?

ML- importance of community sentencing as easier access to drugs services and can maintain links to their treatment providers.

MC – have HMO set up in Thurrock to support prison leavers which can be linked to funding for recovery and dependency?

KM – important to note that Courts can give drug treatment requirements alongside mental health orders etc to be undertaken within the community to prevent future offending and increased difficulty to address concerns once in prison.

JRe thanked KM for a good report and therefore no questions.

Some scope to take on some other crime types sunder flexible cohort, work is being led regionally.
