The Borough of Thurrock (Stopping, Waiting, Loading and On-street Parking) Order 2017

Made 19th June 2017

Coming into force 14th July 2017

The Borough of Thurrock in exercise of the powers under sections 1-4, 32, 35, 45, 46, 49, 51, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and of all enabling powers and after consultation with the Chief Officer of Police of Essex Police in accordance with Part III of Schedule 9 of the 1984 Act hereby makes the following Order, the purpose of which is to incorporate all prohibition or restriction of Stopping, Waiting, Loading and On-street Parking Places into one consolidated Order.

Part 1

General

Commencement and Citation

- (1) This Order shall come into force on 14th July 2017 and may be cited as the Borough of Thurrock (Stopping, Waiting, Loading and On-street Parking) Order 2017 hereinafter referred to as "this Order";
 - (2) The Borough of Thurrock (Stopping, Waiting, Loading and On-street Parking)
 Order 2017 Map Schedule, Map Schedule Legend and other schedules attached to this Order are incorporated into this Order.

Revocations

 This Order revokes the various Orders as listed in Schedule 1 to this Order and all amendments to those Orders insofar as they relate to the prohibition and restriction of stopping, waiting, loading and to on-street parking places.

Interpretation

- 3. (1) Save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by the Traffic Signs Regulations and General Directions 2016 SI No.326 ("the Regulations") as amended:
 - "24-hour clearway" means any length of highway identified as such in the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order and includes the main carriageway, verge or footway, but excludes any lay-by;
 - "blue badge" has the same meaning as "disabled person's badge" in the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 2001 SI No. 682;

"business permit" means a permit issued for employees of businesses to park in a permit parking place or area, or shared use parking place, identified as such in the Map Tile related to that parking place by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order, where the Permit identifier displayed on the business permit is the same as that shown on the sign

located at the parking place and as so identified within the Map Schedule to this Order:

"carer's permit" means a permit issued to the carer of a resident to park in a permit holders parking place or area, or shared use parking place, identified as such in the Map Tile related to that parking place or area by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order; where the permit identifier displayed on the carer's permit is the same as that shown on the sign located at the parking place or area and as so identified within the Map Schedule to this Order;

"civil enforcement officer" means a person authorised by the Council for the enforcement of road traffic contraventions;

"controlled zone" or "permit parking area" means an area introduced by the Council for the administration of permits, as named in Column 3 of Schedule 3, where the permit identifier associated with that controlled zone or permit parking area is specified in Column 1 of that Schedule and indicates that permits bearing the same permit identifier are valid permits for use in a permit parking place within a controlled zone, or permit parking area, where that permit identifier is displayed on the sign in the vicinity of the permit parking place, or on the signs at the entrance to that permit parking area, and in both cases by the inclusion of the same permit identifier in the Map Schedule Legend and/or Map Tile Label related to that permit parking place, or permit parking area, in the Map Schedule to this Order;

"Council" means the Borough of Thurrock Council;

"Council Member" means a duly elected member of the Council;

"delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"driver" means the person driving or having control or charge of a vehicle at any time and in particular in relation to a vehicle waiting in a parking place, the person driving at the time it was left in that parking place;

"footway" has the same meaning as in Section 329 of the Highways Act 1980;

"general prohibition" means the prohibition as set out in Article 13 of this Order;

"goods vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description and is not drawing a trailer;

"healthcare specialist" means a person in the service of a health authority, local authority, central government or any private organisation, whilst engaged in the provision of care or support services and any individual providing pastoral care;

"lay-by" means any area of road intended for use for the waiting of vehicles and lying at the side of the main carriageway and bounded partly by the outer edge of that carriageway on that side of the road;

"local service" has the same meaning assigned to it by s.2 of the Transport Act 1985:

"main carriageway" means any carriageway of the road used primarily by through traffic and includes any carriageway of a slip road, but excludes any lay-by;

"Map Schedule" means a collection of Map Tiles attached to this Order and listed in Schedule 2, which depict the stopping, waiting and loading prohibitions and restrictions and parking places, loading places and parking areas designated by this Order, and in conjunction with the Map Schedule Legend and/or Map Tile Label, identifies the type of each particular type of prohibition, restriction, parking place, loading place or parking area and certain of its governing provisions:

Provided that the Council does not accept responsibility for inaccuracies contained in the Ordnance Survey data relied upon to create the Map Schedule and where a prohibition, restriction, parking place, loading place or parking area is depicted on the Map Schedule, that provision continues to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data;

"Map Schedule Legend" means the Map Schedule Legend to this Order which, when used in conjunction with a Map Tile as listed in Schedule 2, identifies the specific type of stopping, waiting or loading prohibition or restriction and parking place, loading place or parking area designated by this Order and, where appropriate, certain of their governing provisions;

"Map Tile" means an individual Map Tile with a specific tile reference, being part of the Map Schedule, as listed in Schedule 2 to this Order;

"Map Tile Label", where shown on a Map Tile forming part of the Map Schedule in relation to a stopping, waiting or loading prohibition or restriction and parking place, loading place or parking area designated by this Order, means a label on the Map Tile which indicates the type of provision and, if appropriate, certain of its governing conditions;

"motor cycle" means a mechanically propelled vehicle not being an invalid carriage with less than four wheels and the weight of which unladen does not exceed 410 kilograms as provided for by s.253(4) of the Road Traffic Act 1960;

"NHS permit" means a permit issued to a healthcare specialist working for the NHS for use in a permit parking place or area or shared use parking place, identified as such in the Map Tile related to that parking place or area by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order:

"no return" means no return to a parking place within the same street within a specified period;

"Officer" means an employee of the Council;

"operational permit" means a permit issue to an employee of the Council to park in a permit parking place or area or shared use parking place, identified as such in the Map Tile related to that parking place or area by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order;

"operative hours" or "operational hours" in relation to a parking place or parking area, means the period specified in the Map Tile related to that parking place or parking area, by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order;

"owner" in relation to a vehicle, means the person by whom such vehicle is kept and used and in determining who was the Owner of a vehicle at any time, it shall be presumed that the owner was the person in whose name the vehicle was at that time registered under;

"parking bay" means an area contained within a parking place delineated by markings or colour to indicate the position in which a vehicle may be parked;

"parking disc" has the same meaning as given in Regulation 8(5) of the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulation 2000;

"parking place" means an area of highway designated by this Order for the waiting of vehicles of specific classes and indicated on the carriageway by markings in accordance with the Regulations;

"parking ticket" means a ticket issued by a parking ticket machine installed within the vicinity of a payment parking place;

"parking ticket machine" means an apparatus designed to issue a parking ticket indicating the payment of a charge by way of cash or a payment card, for the leaving of a vehicle in a payment parking place and the period in respect of which that charge has been paid;

"passenger vehicle" means a motor vehicle (other than a solo motor cycle) constructed or adapted solely for the carriage of not more than sixteen passengers (exclusive of the driver) and their effects and not drawing a trailer;

"payment" means:

- (a) in the case of a payment of a parking charge in respect of a payment parking place, a payment by coins or payment card; and
- (b) in relation to a permit the method used for the purchase of permits shall be in the form of a cheque, payment card, postal order or any other approved electronic means;

"payment card" means a debit/credit card, or any other accepted form of electronic payment system, that can be used by a person and accepted by a parking ticket machine, or as a means of making a payment for a permit, for the purposes of paying a parking charge;

"payment parking place" means any charged-for parking place designated by this Order and identified as such in the Map Tile related to that parking place by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order;

"pedal cycle" means a vehicle not being a motorised vehicle which has two or more wheels;

"penalty charge" and "penalty charge notice" have the same meaning as in regulations 2(1) and 8(1) of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"permit" means a permit issued by the Council under the provisions of this Order;

"permit identifier" is an alpha, numeric and/or alphanumeric identifier specified in Column 1 of Schedule 3 applicable to the permit parking places or areas specified in Column 3 of that Schedule and used:

a. on permits;

b. on signs at relevant permit parking places or parking areas; and

c. in the Map Tile Labels of such permit parking places and areas in the Map Schedule to this Order;

to identify the permits that are valid for use in such permit parking places and areas to which that permit identifier relates;

"permit holder" means a person to whom a permit has been issued under the provisions of this Order;

"permit parking place" means an area on a highway designated by this Order as a parking place for use by permit holders subject to the provisions of this Order;

"public service vehicle" has the same meaning as assigned to it by s.1 of the Public Passenger Vehicles Act 1981;

"relevant parking place" means any parking place or parking area designated as such by the provisions of this Order in which a valid permit is required to be displayed during the operative hours and shall include any permit parking place, shared use parking place or permit parking area, identified as such in the Map Tile related to that parking place or area by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order;

"relevant position" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"resident" means a person whose principal home is a dwelling with an address within one of the controlled zones or permit parking areas as specified in Schedule 5 to this Order;

"residents' permit" means a permit issued under the provisions of Article 5 of this Order;

"restricted hours" in relation to waiting restrictions in a restricted street, means the times when a prohibition or restriction on waiting applies as identified in the Map Tile relating to that prohibition or restriction by the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order;

"restricted street" means any of the roads, lengths of road or sides of road where any prohibition or restriction of waiting is indicated as being present and is identified as such in the Map Tile relating to that prohibition or restriction by the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order;

"Schedule" or "Map Schedule" means a Schedule or Map Schedule to this Order;

"school entrance marking" means an area of carriageway identified as such in the Map Tile relating to that school entrance marking by reference to the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order and which is contained within the road marking and indicated by the sign prescribed in the Regulations;

"shared use parking place" means any parking place designated as such by this Order and identified as such in the Map Tile relating to that parking place by reference to the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order;

"solo motor cycle" has the same meaning as Section 136 (4) of the Act of 1984;

"street" means any length of highway or of any other street to which the public has access, and includes bridges over which a street passes as set out in s.142(1) of the 1984 Act;

"tariff code" is a payment parking charge identifier specified in the Map Tile Labels for such payment parking places in the Map Schedule to indicate the parking charge applicable at a payment parking place by determining the tariffs in Column 3 of Schedule 7 and the period of charge in Column 2 applicable to that tariff code in Column 1 of that Schedule;

"taxi" means licenced taxi and has the same meaning as in s.13 of the Transport Act 1985:

"timing point" means a recognised timing point which is the location where a public service vehicle may wait to ensure adherence to a published timetable or local service registration and includes departure and terminal points, provided that the location has been approved in writing by the Chief Officer of Police and highway authority;

"traffic sign" or "sign" means a device or object as prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the 1984 Act:

"unauthorised vehicle" means a vehicle not displaying a valid permit;

"universal service provider" has the same meaning as that assigned to it in s.4(3) of the Postal Services Act 2000:

"valid permit" means any permit or dispensation issued under the provisions of this Order and identified as such under Column 2 of Schedule 6 that is required to be displayed in a vehicle left in any parking place or parking area identified under Column 1 of that Schedule where that permit or dispensation complies with the provisions of this Order and the conditions stated in Column 3 of that Schedule;

"valid permit holder" means a person to whom a valid permit or dispensation has been issued under the provisions of this Order;

"vehicles", "motor car", "motor vehicle" and "trailer" are as described in s.185 of the Road Traffic Act 1988;

"visitors parking permit" means a permit issued under the provisions of Article 6 of this Order;

- (2) For the purposes of this Order a vehicle shall be deemed to wait:
- (a) in a restricted street if any point in that street is below the vehicle or its load (if any) and the vehicle is stationary; or
- (b) for more than a specified period in the same place in a restricted street if any one point in that street is below the vehicle or its load (if any) throughout a

- period exceeding the specified period whether or not the vehicle is moved during that period.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (4) Any reference in this Order to a length of street shall, unless otherwise specified, be construed as a reference to the whole width of that length of street.
- (5) The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.
- (6) The singular number shall include the plural number and masculine and neutral genders shall include the feminine gender and vice-versa.
- (7) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

PART II

PERMIT AND PAYMENT PARKING

General provisions applicable to permits

- 4. (1) A vehicle displaying a valid permit will only be validly displaying that permit where:
 - (a) that vehicle does not exceed the dimensions of 5.5 metres by 2.5 metres;
 - (b) the registration number identified on the permit accords with the registration number of the vehicle displaying the permit;
 - (c) it has been issued in respect of the vehicle and is displayed in the front near side corner of the windscreen of the vehicle so that all particulars are visible and can be read in their entirety from the front or near side of the vehicle at all times during which a vehicle is left in a permit parking place or area during the operative hours;
 - (d) the permit holder complies with the specific requirements for displaying of that particular type of permit as stipulated in the Articles 5 to 11;
 - (e) all boxes on the face of the permit have been completed as required by the instructions on the reserve of the permit or on the application form for the permit;
 - (2) If a permit is lost or destroyed the permit holder may apply to the Council for a duplicate permit. Upon the Council being satisfied as to such loss or destruction it may issue a duplicate permit so marked and upon such issue the original permit shall become invalid;
 - (3) The charge for the issue of a permit will be payable in accordance with the provisions of Articles 5 to 11 of this Order and the amount of charge for a permit will be as set out in Column 3 of Schedule 4 to this Order;
 - (4) The Council may at any time before or after the issue of a permit require an applicant for a permit or a permit holder to produce to an Officer of the Council such evidence as they may require in order to verify any information given to them or obtainable by them in respect of the application for a permit;
 - (5) Upon the surrender of a permit to the Council that permit will become invalid;
 - (6) The Council may withdraw a permit at any time before it expires. In order to withdraw a permit the Council must:
 - (a) serve notice of withdrawal in writing on the permit holder and the permit shall thereupon immediately become invalid;
 - (b) the Council shall serve notice by leaving the notice at the address shown on the permit holder's application for the permit or at any other address believed to be the permit holders place of abode; and
 - (c) the permit holder must surrender the permit to the Council within 48 hours of the receipt of the notice.
 - (7) A permit shall cease to be valid at the expiration of the period specified thereon.
 - (8) Where the writing on the face of a permit has been interfered with or altered that permit shall cease to be a valid permit.
- (9) A permit remains the property of the Council at all times and is not transferable. 01 Order 2017

- (10) Permit holders may use the parking places or areas that indicate by way of signing and/or in the Map Tile related to those parking places or areas by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order that the permit is valid for such parking places or areas in accordance with the terms of the permit issued to them and subject to the provisions of this Order provided that a valid permit is displayed in accordance with Article 4(1) of this Order.
- (11) The validity of a permit is confined to the parking places or parking area to which the permit applies as determined by the type of permit and the permit identifier.

Residents' Parking

Residents' permits

- 5. (1) Issue of residents' permits is subject to:
 - (a) a maximum number of residents' permits per household of three. The Council may, in the exercise of its unfettered discretion issue an additional or lesser number of residents' permits per household; and
 - (b) a resident who is the main user of a vehicle which falls into one of the following categories may apply to the Council for a residents' permit:
 - (i) a passenger vehicle; or
 - (ii) a goods vehicle

and any such application shall be on an application form issued by the Council and shall include the information requested on the application form. The appropriate fee as referred to in Article 4 (3) of this Order and specified in Column 3 of Schedule 4 to this Order must be paid when a resident submits an application form for a residents' permit.

- (2) On receipt of an application made in accordance with this Article and where the Council is satisfied that the applicant is:
 - (a) a resident in respect of the permit zone or area for which the residents permit has been applied for;
 - (b) and is the main user of the vehicle to which the permit relates;
 - the Council may issue to the applicant a residents' permit which shall allow the applicant to leave their vehicle during the operative hours in a resident permit parking place or area as is identified on the permit by the permit identifier;
- (3) Notwithstanding the foregoing, the Council may in the exercise of its unfettered discretion issue a residents' permit to any resident, who appears to the Council to be the main user of a vehicle falling into one of the categories as specified in Article 5(1)(b) above;
- (4) A residents' permit must be displayed in accordance with Article 4(1)(c) of this Order.

Visitors Permits

 (1) Any resident may purchase from the Council visitor's permits for the fee as described in Column 3 of Schedule 4 to this order;

- (2) A visitor's permit will only be validly displayed if in accordance with the provisions of Article 4 (1) (c) of this Order;
- (3) When so displayed the visitor's permit will remain valid for the maximum duration printed thereon. It shall be permissible to cover longer visits by displaying several completed and valid visitor's permits in advance;
- (4) Only two visitor's permits shall be used or displayed at any one time in respect of one dwelling. The Corporate Director of Regulatory Services (or such other Officer appointed by the Council) may in the exercise of their unfettered discretion permit an additional number of visitor's permits to be displayed at any given time in respect of one dwelling;
- (5) Before displaying a visitor's permit the driver of the vehicle to which it is affixed shall ensure that the visitor's permit has been completed in the manner specified on the visitor's permit to show the date and time when the vehicle was left within the parking place or area;
- (6) The Council may at any time before or after the issue of the visitor's permit require an applicant for a visitor's permit or a visitor's permit holder to produce to an Officer of the Council such evidence as they may require in order to verify any information given to them, or obtained by them, in respect of the application for a visitor's permit

Estate Agent's Permit

- The Council may in the exercise of its unfettered discretion issue an estate agent's permit to an estate agent to park in the zone(s) and/or areas specified on the permit;
 - (2) The estate agent's permit will specify the address of the premises of the applicant and will only be used by persons employed at that address;
 - (3) Estate agent's permits will be displayed in accordance with the provisions of Article 4 (1) (c) of this Order and shall specify the address being visited by the estate agent permit holder on each visit.

Health/Carer Worker's Permits

- 8. (1) Upon written application by a health/carer worker on a form approved by the Council and payment of the appropriate fee as described in Column 3 of Schedule 4 to this Order the Council may issue the applicant with a health/carer worker's permit in respect of the use of a resident's parking place contained in any one or more zones or areas whenever the Council considers it reasonably necessary for the exercise of a health/carer workers' duties;
 - (2) The information which the Council deems necessary will be recorded on the health/carer worker's permit, which will be issued upon the application being accepted by the Council and payment of the appropriate fee as specified in Column 3 of Schedule 4 to this Order;
 - (3) The health/carer worker's permit will be displayed in accordance with the provisions of Article 4 (1) (c) of this order and shall specify the address being visited by the health/carer worker permit holder on each visit.

Operational Permits

- 9. (1) Upon written application by a Council Member or Officer on a form approved by the Council, the Council may issue the applicant with an operational permit in respect of the use of resident's parking places or area contained in any one or more zones whenever the Council considers it reasonably necessary for the exercise of a Council Member's or Officer's respective duties;
 - (2) The information which the Council deems necessary will be recorded on the operational permit, which will be issued upon the application in Article 9 (1) of the Order being accepted by the Council;
 - (3) The operational permit will be displayed in accordance with the provisions of Article 4 (1) (c) of this Order.

Other Permits

Business Permits

- 10. (1) The Council may, in exercise of its unfettered discretion, upon receipt of a written application on a form approved by the Council and upon the payment of the appropriate fee as specified in Column 3 of Schedule 4 to this Order, issue a business permit to any individual employed in a business the address of which is within a permit parking zone or area as specified on the business permit. The business permit shall relate to a specific vehicle and will not be issued for the business in general.
 - (2) Business permits will be displayed in accordance with the provisions of Article (4) (1) (c) of this Order.

Doctors / NHS Permits

- 11. (1) The Council may in exercise of its unfettered discretion issue a doctor's permit to a doctor for use in a designated doctor's parking place identified as such in the Map Tile relating to that parking place by reference to the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order. The doctor's permit shall relate to a specific vehicle and will not be issued for the doctor's practice in general.
 - (2) The Council may, in exercise of its unfettered discretion, issue a NHS permit to a Healthcare specialist for use in any permit parking place or area identified as such in the Map Tile relating to that parking place by the Map Schedule Legend and/or the Map Tile Label in the Map Schedule to this Order.

Payment Parking

Payment Parking Places

- 12. A vehicle will only be validly displaying a payment parking ticket where it complies with the following:
 - (a) A payment parking ticket valid at that time has been obtained from an appropriate payment parking ticket machine by the driver of the vehicle paying the appropriate charge, as indicated by signing in the vicinity of the payment parking place and by the Tariff Code in the Map Tile Label related to that parking place in the Map Schedule by identifying the same Tariff Code in Column 1 of Schedule 7 to this Order and the charges applicable to that tariff code in Column 3 of that Schedule,

- by inserting the correct money in a payment parking ticket machine provided for that payment parking place;
- (b) The payment parking ticket is displayed in a prominent position within the vehicle so that it can be read in its entirety from the outside of the vehicle in accordance with the provisions of Article 4 (1) (c) of this Order.

PART III

PROVISIONS APPLYING BOTH TO THE PARKING PLACES AND TO PROHIBITIONS AND RESTRICTIONS ON WAITING

General Prohibition on Stopping or Waiting of Vehicles

- 13. Save as provided in Article 15 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit:
 - (a) any vehicle to stop or wait on areas of the street or sides of the street where stopping or waiting is not allowed, on the days and at the times defined in the Map Schedule Legend and/or Map Tile Label as identified in the Map Schedule to this Order: or
 - (b) any vehicle to stop or to wait on the main carriageway, verge or footway comprised in the lengths of road specified as 24 hour clearways in the Map Schedule Legend and/or Map Tile Label as identified in the Map Schedule to this Order.

Contravention of the General Prohibition

14. Where a person contravenes the general prohibition set out in Article 13 of this Order and does not fall into any one of the exemptions set out in Article 15 of this Order the owner of the vehicle in question shall incur a penalty charge.

Exemptions to the General Prohibitions

- 15. (1) The following are exempt from the general prohibition as set out in Article 13 of this Order:
 - (a) a vehicle, necessarily required for use in connection with any if the following operations, namely:
 - (i) the removal of any obstruction to traffic;
 - (ii) the maintenance, improvement or reconstruction on the: areas of streets or sides of street with respect to Article 13 (a); and road comprising the carriageway, verge or footway with respect to
 - road comprising the carriageway, verge or footway with respect to Article 13 (b);
 - (iii) the laying, erection, alteration or repair in or on land adjacent to the Streets, lengths of Streets or sides of Streets of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line by a utility organisation while attending to their apparatus; or

- (b) in relation to a vehicle being used -
 - (i) for police, ambulance or fire and rescue authority purposes;
 - (ii) a vehicle in the service of a local authority in pursuance of statutory powers;
 - (iii) in the service of water or sewage undertakers within the meaning of the Water Authority Act 1991; or
- (c) in relation to a vehicle waiting when the person in control of it is -
 - (i) required by law to stop;
 - (ii) obliged to stop in order to avoid an accident; or
 - (iii) prevented from proceeding by circumstance outside the drivers control;
- (d) a public service vehicle whilst at an authorised stopping place terminal or timing point;
- (e) a taxi whilst at an official taxi rank;
- (f) a vehicle being used to attend an emergency by a Doctor or District Nurse or Midwife. The Council may require evidence to show that there was an emergency.
- (g) a vehicle validly displaying a blue badge in the circumstances prescribed in Regulations 7, 8 or 9, but subject to the limitation set out in Regulation 6(2) of the Local Authorities' Traffic Orders (Exemptions for Disable Persons) (England) Regulations 2000 SI 683;
- (h) a vehicle validly displaying in the relevant position a blue badge parked in any residents' parking place at any time;
- (i) a vehicle that is waiting only for so long (and in any event no longer than 20 minutes) so as to enable goods to be loaded on or uploaded from the vehicle, save on the areas of a street or sides of a street where loading or unloading are specifically regulated, as identified and defined for the periods stipulated in the Map Tile related to that length of street by the Map Schedule Legend and/or Map Tile Label in the Map Schedule to this Order;
- a vehicle that is waiting only for so long as is necessary to enable a person to board or alight from that vehicle;
- (k) a vehicle validly displaying a dispensation ticket in accordance with the provisions of Article 17 of this order;
- a vehicle in the service of a universal service provider being used for the purpose of delivering or collecting postal packets;
- (m) a vehicle validly displaying a valid permit issued under one of the Articles 5 to 11 of this Order;
- (n) a motor cycle parking in any residents' permit parking place, or permit parking area or payment parking place at any time;
- (o) a vehicle displaying a valid parking ticket insofar as it is parked within a payment parking place as shown in the Map Tile related to that parking place

- and identified as such in the Map Schedule Legend and/or Map Tile Label for that parking place in the Map Schedule to this Order;
- (2) If and insofar as a vehicle described in Articles 15(1)(h)-(o) of this Order is parked in a parking bay that the vehicle must be wholly parked within that parking bay.

Power to Suspend use of Parking Places

- 16. (1) Upon written application on a form approved by the Council and upon payment of the appropriate fee as described in Schedule 8 to this Order to the Council, the Council may direct that the use of a parking place or any part thereof be suspended whenever it considers such suspension necessary in the exercise of its unfettered discretion:
 - (2) for the avoidance of doubt nothing in this Article restricts in any way the discretion afforded to the Council to stipulate such conditions to or grant such exemptions for any suspension directed in accordance with Article 16(1) hereof as it considers necessary on the exercise of its unfettered discretion;
 - (3) a police constable in uniform may direct the suspension of the use of a parking place or any part thereof whenever they consider such suspension necessary in the exercise of their unfettered discretion for the purpose of facilitating the movement of traffic or promoting its safety or that of the public;
 - (4) where the Council directs that the use of a parking place or any part thereof be suspended in accordance with the provisions of paragraph (1) of this Article the Council will place or cause to be placed in or adjacent to that parking place or part thereof traffic signs indicating that vehicles are prohibited from parking or waiting thereon;
 - (5) no person shall cause or permit a vehicle to be left in any suspended parking place or any part thereof:
 - (a) during such a period as any suspension directed in accordance with this Article is in force in respect of that parking place or any part thereof; and
 - (b) whilst there are in or adjacent to that parking place or part thereof traffic signs placed in accordance with Paragraph (4) of this Article or placed by the police;
 - (6) where a person contravenes the Article 16(5), that person shall incur a penalty charge.

Power to Dispense with the General Prohibition in respect of a Parking Place

- 17. (1) Upon application and payment of the appropriate fee in accordance with Schedule 8 the Council may grant a dispensation ticket or dispensation tickets restricted to a specified location and for a specified period, whenever it considers such grant reasonably necessary for:
 - (a) a wedding, a funeral or similar religious or civil ceremony; or where no reasonable alternative exists for other gatherings; or
 - (b) the erection of scaffolding works for repair, building operation, demolition, excavation, maintenance, improvement or reconstruction to or at a dwellinghouse or business premises; or

- (c) the convenience of occupiers of premises adjacent to the location on any occasion for the moving of furniture to or from such premises; or
- (d) an event organised by a registered charitable organisation
- (2) A Vehicle displaying a Dispensation Ticket is exempted from the General Prohibition in respect of the location specified for the period and date specified.
- 18. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment replacing or amending the same.
