The Borough of Thurrock (London Road, West Thurrock) (Weight Restriction) Order 2025

STATEMENT of REASONS

The Council proposes to amend the existing 7.5t weight restriction as part of an environmental improvement scheme and to assist in camera enforcements. The restriction restricts all vehicles over a maximum gross weight of 7.5 tonnes" from proceeding on London Road between Motherwell Way to West Thurrock Way and the surrounding residential roads the restriction is to be amended as below.

- a) Revoke the existing Prohibition of Driving "Prohibited Access Good Vehicles Exceeding 7.5t Except for Loading" on the lengths of road specified below:
 - i. London Road, from Motherwell Way to West Thurrock Way.
- b) Introduce a new Prohibition of Driving "Prohibited Access Good Vehicles Exceeding 7.5t Except for Loading" on the lengths of road specified below:
 - i. London Road, from Motherwell Way to a point 30m east of the western kerb line of Elm Terrace
 - ii. Access Road for 3 to 6 The Bungalows
 - iii. Elm Terrace
 - iv. Essex Road
 - v. Fifth Avenue
 - vi. First Avenue
 - vii. Flint Street
 - viii. Fourth Avenue
 - ix. Fox Field Close
 - x. Hillcrest Avenue
 - xi. Hilltop Road
 - xii. Jubilee Road
 - xiii. Park Avenue
 - xiv. Sartoria Close
 - xv. Schoolfield Road
 - xvi. Schoolfield Way
 - xvii. Second Avenue
 - xviii. St Clements Avenue
 - xix. The Rookery
 - xx. Third Avenue

TRAFFIC REGULATION ORDER

The Borough of Thurrock (London Road, West Thurrock) (Weight Restriction) Order 2025

Thurrock Borough Council in exercise of the powers under sections 1, 2, 3, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order.

- 1. The Order shall come into operation on the XXXX 2025 and may be cited as The Borough of Thurrock (London Road, West Thurrock) (Weight Restriction) Order 2025.
- 2. In this Order the expression "enactment" means any enactment whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment

"Telecommunication system" has the same meaning as in the Telecommunications Act 1984;

The expression "goods vehicle" and maximum gross weight have the same meanings as in the Traffic Signs Regulation and General Directions 2016.

- 3. Save as in article 4 of this Order, no person shall except upon the direction or with the permission of a police officer in uniform cause or permit any goods vehicle with the maximum gross weight which exceeds 7.5 tonnes to proceed in the lengths of roads specified in Schedule 1 to this Order.
- 4. Nothing in Article 3 of this order shall make it unlawful for a person to cause or permit any goods vehicle the maximum gross weight which exceed 7.5 tonnes to enter on or proceed in any lengths of road specified in schedule 1 to this Order if the vehicle is being used:
 - a) In connection with the carrying out in the highway, or at premises situated on or adjacent to the highway, or on any road or at any premises accessible only from that length of road, of any of the following operations, namely:
 - i. Building, industrial or demolition operations
 - ii. The maintenance, improvement or reconstruction of the road



- iii. The laying, erection, alteration or repair in, or on the land adjacent to the prescribed street(s) of any sewer or any main, pipe or apparatus for the supply of water, gas, electricity, or any telecommunications apparatus as defined in schedule 2 to the Telecommunications Act 1984; or
- b) In the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstance it is reasonably necessary in the exercise of such duties for that vehicle to proceed I that length of road:
- c) For fire brigade, police, or ambulance purposes; or
- d) For goods to be loaded or unloaded from the vehicle
- 5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
