



TRAFFIC REGULATION ORDER

The Borough of Thurrock (Dell Road, Grays) (Revocation of Permit B Holders Only Parking Bays and Implementation of No Waiting At Any Time Restrictions) Order 2026

STATEMENT of REASONS

The Council proposes to revoke Permit B Holders Only (Mon-Sat 9am-6pm) parking bays and implement Waiting Restrictions “No Waiting at Any Time” at the locations listed below to prevent obstruction and to maintain traffic flow on the highway.

The general effect of the Order would be to: -

- a) Revoke Permit B Holders Only (Mon-Sat 9am-6pm) parking bays at the following location:
 - i. On eastern side of Dell Road from a point 21m north of the northern kerb line of Orsett Road in a northern direction for a distance of 52m.

- b) Implement “No Waiting At Any Time” restrictions at the following location:
 - i. On the eastern side of Dell Road from a point 21m north of the northern kerb line of Orsett Road in a northern direction for a distance of 21m.
 - ii. On the eastern side of Dell Road from a point 46.8m north of the northern kerb line of Orsett Road in a northern direction for a distance of 17.2m.
 - iii. On both sides of the access road leading to the new care home from the eastern kerb line of Dell Road in an easterly direction for a distance of 7.7m.

Thurrock Borough Council in exercise of the powers under sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as “the 1984 Act”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act, hereby make the following Order.

1. The Order shall come into operation on the 00th Month 2026 and may be cited as The Borough of Thurrock (Dell Road, Grays) (Revocation of Permit B Holders Only Parking Bays and Implementation of No Waiting At Any Time Restrictions) Order 2026.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Borough of Thurrock (Stopping, Waiting, Loading and On-street Parking) Order 2017 shall have effect as though:
