

PUBLIC NOTICE

The Borough Council of Thurrock - Various Roads, West Thurrock, Grays, Stanford Le Hope, Linford, South Ockendon (Temporary Prohibition of Traffic)

No. 128 Order 2025

- 1) The Borough Council of Thurrock, in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all other powers, intends to make an Order the effect of which is to: -

Prohibit any vehicle from parking At Any Time along various lengths of road in Thurrock as per Schedule 1 to this Order.

- 2) The purpose of the Order is to enable Thurrock Council to carry out Footway Reconstruction.

The Order will come into force on 11th August 2025 at 08:00hrs. It only applies to those days and times when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. Diversion routes will be signed at each location and residents will be informed of each closure via letter / leaflet drop and advanced warning signs on the road. The roads will be closed to facilitate each phase and then re-opened to the public.

- 3) Traffic Signs Regulations and General Directions 2016. Diversion routes will be signed at each location and residents will be informed of each closure via letter / leaflet drop and advanced warning signs on the road. The roads will be closed to facilitate each phase and then re-opened to the public.

- 4) It is expected that the works will be completed within the times stated on the schedule to the Order, however the Order will continue in force for a period not exceeding 18 months or until the works have been completed, whichever is the sooner.
