Long Lane and Highfield Gardens - Grays

(Temporary prohibition or restriction on roads)

No. 025 Order 2026

- 1) The Borough Council of Thurrock, in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all other powers, has made an Order the effect of which is to: -

Prohibit any vehicle from travelling along Long Lane and Highfield Gardens in accordance with Schedule One to the Order.

Prohibit any vehicle from parking At Any Time along both kerb lines of Long Lane and Highfield Gardens in accordance with Schedule One to the Order.

- 2) The purpose of the Order is to enable Thurrock Council to carry out installation of speed cushions.
- 3) The alternative routes are as per Schedule One to the Order. Access will be maintained for residents and businesses at all times.
- 4) The Order will come into force on the 20th February 2026 at 08:00hrs. Works are currently scheduled to take place on 20th February 2026 and then daily between 16th and 17th March 2026 between the hours of 08:00 and 17:00. Exact dates however will always be specified on <https://one.network/?tm=GB147722597> It only applies to those days and times when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016.
- 5) It is expected that the works will be completed within the above times, however the Order will continue in force for a period not exceeding 18 months or until the works have been completed, whichever is the sooner
- 6) If the works are not completed within 18 months, the Order may be extended for a longer period with the approval of the Secretary of State.
